Victor is the earliest Reece ancestor we have documentation for. His connection to the more recent generations is proven by the 1860 Census of Knox County, Missouri as well as his estate settlement cited below.

Parents

No solid evidence has been found identifying Victor's parents. However, there are bits that merit further study. Beginning with the idea that Victor was an immigrant, we can surmise that he came to America as a child or youth and married as a older teenager or very young adult. Couple that with an entry on Ancestry.com which substitutes the name of Johanes Joe Reiese for Victor's name. Add the fact that the name Catherine Reece is listed in Union County, PA census of 1830. A source titled; Pennsylvania German Pioneers, A publication of the original lists of arrivals in the Port of Philadelphia from 1727 to 1808, Volume II, shows that a Johanes & Catherina Rees arrived on the "Brig Peggy" February 13, 1797 from Amsterdam. It is plausible that Victor was the son of Johannes (John) Rees. Trivial though it may be, remember that one Victor had one son named John and another Joseph.

Siblings

Family lore tells us Victor Reece came to America with brothers, Joseph and Franklin from Switzerland. I have not been able to connect Victor with any siblings. However, he is probably related to the other Reeces named in the 1830 census of Union County, Pennsylvania. I have not been able to access the 1820 Census of Union County which was formed in 1813 from Northumberland. It is possible that Victor was in Northumberland County in 1810 where I find three Reeces listed: Abraham, George and N.. What if any connection any of these three had to Victor is unknown. Remember that only the heads of households were named in the 1790 through 1840 Federal Census.

Place of birth

Likewise, there is disagreement about place of birth. The 1900 and 1910 census reports of Joseph Reece indicate his Victor was born in Switzerland. However, his brothers James and John as well as sister Margaret indicated their father was born in Germany. The 1860 Census report of Knox County, Missouri which lists Victor as a resident in his son, Joseph's household, clearly gives place of birth as "Cicily". I feel that is most likely an error but what was it really suppose to say? Could it be that Victor was born in while his parents were en-route to America?

Time of immigration

The later census records all support the statement that Victor was an immigrant which raises the question of when did he immigrate. Without more evidence, it is very difficult to say when Victor arrived in America. I understand Victor married Lydia Jane Cornelius in Pennsylvania, probably between 1810 and 1813. All of Victor's children indicated their mother was born in Pennsylvania. Union County was formed from Northumberland County in 1813 so the marriage was probably in Northumberland County. The various census reports support the idea that Harriet was the oldest child and that she was born as early as 1812 and as late as 1816. If the 1812 birth date for Harriet is correct, the 1797 birth date of Victor is probably an error as he would have only been about 15 years old. The probably that Victor was born earlier than 1797 is also supported by the interpolated birth date of his wife as 1794. She would have been approximately 17 years old at the time of Harriet's birth which would not be unusual. Putting these various pieces together, we can deduce that Victor, if an immigrant, arrived in the United States between 1794 and 1810. The family probably arrived at the Port of Philadelphia but this doesn't mean the family went directly to Northumberland County although it certainly could have.

First record

The 1830 Census of Union County, Pennsylvania is our earliest documentation of Victor Reece and his family. The 1830 census data coincides well with our subsequent research. There are two things to note. First, Victor's youngest daughter, Lydia Jane, does not appear on the 1830 census. Secondly, we can only speculate about the identity of the 80 to 90 year old male in the list. Victor was probably in his upper 30's at the time of 1830 census so there would have been a time gap of at least 40 years between Victor and the older man. The older man could have been either Victor or Lydia's father or grandfather.

I feel that Barbara Rees was possibly a sister-in-law of Victor's. Most likely, Rees was her married named supported by the presence of a male and female in her household who were probably her children. Other Reeces in Union County, PA in 1830 included Catherine, Daniel, G.W., an unnamed widow, and Simeon. Anyone or all of these could be part of our family.

Victor & family in Jackson County, Ohio

Victor moved to Jackson County, Ohio between 1830 and 1836. He was listed in Buffalo Township of Union County, Pennsylvania in 1830. His wife's death and grave record locates him in Jackson County, Ohio in 1836. Lydia is buried in the Bundy Paine Cemetery of Milton Township. The cemetery is approximately ½ mile north of the community of Wellston, OH.

Lydia Reece's gravestone reads:

"This languishing head is at rest, Its thinking and aching are o'er.
This quiet immoveable breast is heaved by affliction no more."

The 1850 census of Washington Township, Jackson County, Ohio, family #1493 lists James Rees as the head of the household at age 29 with Joseph Reece, age 21, residing in the same household. Both were listed as born in Pennsylvania supporting the interpretation that they were Victor and Lydia sons. James relocated to Wapello County, Iowa in the 1850's.

Victor's son James married Nancy Anthony in Jackson County, Ohio in August 17, 1843.

Victor's son Joseph, married Elizabeth Baccus Garfield in Jackson County, Ohio June 7, 1851.

Victor's daughter, Margaret, married Reuben Stoner in Jackson County, Ohio August 5, 1851.

Victor Reece in Wapello County, Iowa

The identification of the children of Victor and Lydia are found in part in the estate papers of Victor Reece filed in Knox County, Missouri January 20th, 1864 by Joseph Reece.

The United States of America to all to whom these presents shall come, greetings:

Whereas Victor Reece of Wapello County, Iowa has deposited (with) the general land office of the United States a certificate of the Register of the Land Office at Palmyra, Marion County, Missouri, it appears that full payment has been made by the said Victor Reece according to the provisions of the Act of Congress of the -- of April, 1820 entitled an act making further provision for the sale of public lands for the south half of the south east quarter of section two and the north half of the north east quarter of section 11 in township 63 of Range twelve west in the district of lands subject of sale at Palmyra, Missouri containing one hundred and sixty acres.

According to the official plat of the survey of the said lands returned to the general land office by the surveyor general which said tract has been purchased by the said Victor Reece. Now know ye that the United States of America in consideration of the premises and in conformity to the several acts of Congress in such case made and provide herein give and grant unto the said Victor Reece and to his heirs the said tract of land above described to have and to hold the same with all the rights, privileges --- and appurtenances of whatever nature thereunto belonging t the said Victor Reece and to his heirs and assigns for ever.

In testimony whereof I James Buchanan President of the United States of America have caused these letters to be made patents and the seal of the general land office to be hereunto given under my hand at the City of Washington the twenty seventh day of October in the year of our Lord one thousand eight hundred fifty eight and of the Independence of the United States the Eighty seventh.

* **Compiler's note:** It is interesting to note that the patent was for 160 acres but the land sold later in the estate settlement appears to have been only 81 acres.

It appears that Victor Reece died at the home of his son, Joseph near Greensburg in Knox County, Missouri. However, to this date, his place of burial remains unidentified. It is entirely possible that he was buried on his own property which was a common practice of that period. There is a peculiar entry in the records of Bundy Paine Cemetery, Jackson County, Ohio for a Victory Reece. I have interpreted it to refer to Victor's wife Lydia. Otherwise, it could be referring to a previously unidentified son by the name of Victor.

Miscellaneous Notes on the Reece and Cornelius Families in Pennsylvania

These notes may or may not refer to our specific families but are being recorded here for future reference should new information be added.

Union County, Pennsylvania

Dietrick Rees had a survey which became New Columbia, Pa. by 1769.
Abel Reese settled in East Buffalo Township in 1783. He lived there as early as 1780 and was a supervisor there in 1781. He died in 1792.
Simon Reese taught at Kelly School, Kelly Township in 1817 and also Hill School.
Daniel Reish was from Berks Co., Pa. and had a son Benwell who in turn had James K & Joel.
Daniel Rees lived in Buffalo Township, Union County, Pa from 1775 to 1805 with wife Catherine and children Catherine and George W. He bought land there 6/21/1780.
Mary A. Reese was a member of the Beaver Memorial Methodist Church. (date unknown)
John and Daniel Reese were listed as single men in Buffalo Township in 1795.
Daniel Reese operated a still-house in Lewisburg, Pa. in 1793.
John Cornelius moved to Union County, Pa. from Chester County, PA where ~~James~~ was born in 1783.
J.R. Cornelius was publisher of the Lewisburg Chronicle ca. 1870.
